3. Applicant should not have any outstanding fees with SINU's Registrars' office, since the SIG-MCILI **will not** be accountable for any fee arrears. Confirmation note from SINU Accounts Office is necessary.
4. Applicant intending to show commitment, responsibility and respect for the program and the regulations both from this office and SINU/STMS can apply.
5. Applicant to provide and attach all transcripts for Academic and Skills Performance attainments starting from the first year at STMS and recommendation and confirmation letters from both your Program Mentor and Head of School (STMS).
6. Applicant providing any false or misleading information, for convincing purposes to secure a sponsorship will have his/her application rejected.
7. The Supervisor's decision is final and the Government funding allocation for this sponsorship program will determine the number of accepted students for 2017.
8. Upon successful consideration of your application, SIG- MCILI will be responsible for sponsorship until the completion of your C4 program. This sponsorship covers Registration, Tuition, Meal (Lunch only) and Student Allowance among other support that will be agreed in a Contract to be signed with SIG-MCILI.
9. The due date for the application is **31<sup>st</sup> October 2016 at 4:30pm**. Any application submitted after the due date may not be considered. Noncompliance to any of the stated criteria will result in disqualification of that application.
